His book "British Theatre" (1834) collected together 399 plays in 48 volumes. In 1829, he successfully defended rights of publishers over performance as well as the text, for a play he held in copyright, a control which was not overcome until the 1842 Copyright Act. He was recorded among 'Memorable residents of Islington, Barnsbury and Pentonville' in *Notes & Queries* 1882; 2 September p182. 'At Cumberland Lodge, 123 Camden Road, resided some years ago the proprietor of Cumberland's Acting Drama. He was foreman of the jury held at the Camden Arms, before Mr T Wakley MP on the death of Colonel Fawcett who died of a duel he fought with Lieut. Munro on 1 July 1843 in a field near Brecknock Arms Tavern.'

Cumberland has 33 prints as publisher in the British Museum 1820-1843 mainly of dramatic characters.

John Darlington's daughter, Mary Anne, in 1844 married Daniel Puseley, a textiles businessman in the City. Puseley travelled to, and wrote about Australia, as well as poetry and drama. They had four sons, two of whom became journalists overseas. In 1868, rather notably, Puseley "gave a banquet, the first of its kind, to six hundred ragged-school children, at St. James's Hall." (St James' Hall in Piccadilly was the gothic-decorated main concert hall of Victorian London.) However, he later lost his fortune in overseas holdings and died (in 1882) age 68 at 21 Rochester Road.



Robert Pulford had Pulford was recorded as a tailor in St James, London, in 1823, when he undid a partnership. He was mentioned first by Kay Sept 1828: 'Allen of Kensington has been in touch about leases for Pulford – a government tailor of St James'. His building started in 1834-37 with double cottages on the north side of Camden Road and 12 houses in Bayham Terrace, south of Camden Road and two adjoining in Camden Street; and in a second take from 1839 for 4 houses on the west side of Camden Street and thirteen houses in Hamilton Street.

Later his address was 65 St James: from this address he was a petitioner with Henry Pulford against a bankrupt business in 1844 and with Alfred Pulford as members of the Committee of Management of the Art Union on London in 1846. Pulford was a signatory of the Memorial for the church. His daughter Emily-Sophia married in 1853.
